Fuel and vendor surcharges may be assessed.

### Payment Terms and Conditions:

1. \$250.00 per person is due with names immediately, to hold your reservation.
  - \$100.00 per person penalty upon deposit.
2. Second Payment of \$500.00 per person is due by November 1, 2025.
3. Third Payment of \$1000.00 per person is due by January 30, 2026.
4. Final payment is due by April 27, 2026.
5. Travel Protection, on an individual basis, should be forwarded to PML Tours as people give their initial deposit.
6. Cancellation Penalty begins immediately upon receipt of your deposit:
